6: GRANTS AND DONATIONS 2020/21

The following statement has been added to the Grant Application form as agreed by Council:

"In recognition of the current **exceptional times**, the Finance Committee may consider and make recommendations relating to grant applications received outside of the set criteria and Annual Grant Scheme deadline, at the Committee's discretion – providing they do not contravene the rules of what Council is allowed to do under S137."

For 2020/21 the budget allocated to grants is $\pounds 2,000$ from which two grants have been paid: Pentrich & South Wingfield Revolution Group $\pounds 150$, Amber Valley First Responders $\pounds 200$. The Council has a balance of $\pounds 1,650$ in the grant budget.

Please note: Glebe Field Centre Management Committee have requested that their application for funding be deferred to the next Meeting in April, when they should be able to provide the necessary information.
