## ALLOTMENTS, BURIAL GROUND, JUBILEE GROUND, FOOTPATHS WORKING PARTY

## 0265/24 RECREATION GROUND

## a) Goal Mouths

Unfortunately we have been let down by our contractors, they will no longer be able to repair the goal mouths before the summer. Hopefully this work will be done in the Autumn.

## b) Train

The panel on the train has been replaced, this needed replacing due to water damage.

Thank you to David Creed & Cllr Baugh for replacing this. Another panel will be ordered to keep in the basement.

The train roof has been damaged and needs to be replaced.

Can we respectfully ask residents not to climb on the roof of the train, while it is safe for children to play on, the train is not designed for adults to climb on top of it.

## c) Matting

The matting underneath the swing will be replaced by David Creed. We are obtaining quotes to repair the rest of the matting.

## d) Hole in Football Pitch

The large hole in the football pitch was to be repaired along with the goal mouths, so will not be done before the summer.

The small holes will be repaired by David Creed.

The Parish Council would like to respectfully ask people not to let their dogs dig holes on the football pitch. Thank you.

## 0266/24 ALLOTMENTS

a) Access road to the allotments

The access road is in need of repair, quotes are being obtained by the Project Officer. Cllrs Walsh & Baugh made a visit to the allotments to look at the damage to the access road. There are a number of natural springs around the area and water runs down the road when it rains which has caused the damage. It was felt that continuous patching of the holes as they occur would be a better solution to having the road resurfaced as it was felt the repair could never be permanent due to continuous damage by the natural springs.

Contractors will be contacted for quotes with this view in mind.

- b) A request has been made by an allotment user for Crich Parish Council to remove brambles on the allotments, this will improve parking.
  The working party made a visit to the allotments to look into the request they could only find a small area of brambles, but were told by allotment holders that it would not be safe to park there as the road falls away underneath the brambles and that is why they are there.
  No further action will be taken.
- c) Thefts have been reported from several allotment plots. 7 plastic chairs have been stollen from various plots. This has been reported to the police. Some chairs have since been found in the local quarry.

## 0267/24 BURIAL GROUND

## a) Signage

An email has been received with concerns that dogs are being exercised in the burial ground. We do not currently have signs asking owners to keep dogs on a lead and to clean up after your dog. These signs will be ordered and installed once a suitable location has been established. Quotes for a notice board have been obtained.

## b) Memorial Testing

Memorial Testing will begin in the Crich Burial Ground in Summer/Autumn 2024, exact date to be confirmed.

The memorials will be tested by hand, we will not use a force measuring device.

Unsafe headstones will be made safe by staking & binding.

A notice will be attached to the unsafe headstone & the next of kin will be informed.

Quotes for external testing companies have been obtained.

Cllrs Yorke & Broom have recommend CDS for testing.

**Resolved:** To contact CDS and make arrangements. Ask if the contractor can also stake and bind any unsafe memorials.
